Beginning at a 5/8 inch Rebar found in the centerline of the Vacated Elm Street (25 feet wide) and being in the south line of Park Drive (60 feet wide), this point now being the northwest corner to Lot No. 197;

Thence with the north line of Lot No. 197 and the south line of Park Drive, N.  $55^{\circ}06'52"$  E. 20.00 feet to a point;

Thence parallel with the centerline of Vacated Elm Street and the new west line of Lot No. 197, S.  $34^{\circ}53'08"$  E. 106.07 feet to a point;

Thence with an extension of the north line of Lots No. 198, 199 and 200, S.  $38^{\circ}45'58"$  W. 7.82 feet to a 5/8" x 30" Rebar set at the northeast corner to Lot No. 198 and an interior corner to the Vacated Elm Street;

Thence N.  $84^{\circ}44'52"$  W. 16.35 feet to a R. R. Spike found at an angle point in the centerline of Vacated Elm Street and a corner to Lot No. 197;

Thence with the centerline of Vacated Elm Street and the new west line of Lot No. 197, N.  $34^{\circ}53'08"$  W. 97.73 feet to the place of beginning, (Note: This line is the Basis of Bearing for this Easement).



Thence N.  $43^{\circ}58'14"$  W. 38.96 feet to a 5/8" x 30" Rebar set at the southwest corner to that part of Lot No. 227 in the name of Steven K. Yoder et ux as recorded in Official Record No. 327 Page 783 (6-20-1997), passing through the south line of Lot No. 227 at 31.96 feet;

Thence with the south line of Yoder's tract, N. 53°56'52" E. 95.54 feet to a R. R. Spike found at the southeast corner to Yoder's tract and in the centerline of vacated Elm Street, (Note: This line is the Basis of Bearing for this survey - N. 53°56'52" E.);

Thence S.  $84^{\circ}44'52"$  E. 16.35 feet to a 5/8" x 30" Rebar set at the northeast corner to Lot No. 198 and being in the west line of Lot No. 197;

Thence with the north line of Lots No. 198,199 and 200, S.  $38^{\circ}45'58"$  W. 106.15 feet to the place of beginning, passing through a 5/8" x 30" Rebar set at 34.81 feet and 69.62 feet, containing 2,567.015 square feet or 0.059 Acres, more or less.






