Being situated in Washington Township, Logan County, Ohio; and being a part of V.M.S. #9925-9946-10121.

Beginning at a iron at the northwest corner of Lot #1 of Waterbury's Summer Resort Allotment.

Thence with the west line of said Lot #1 S7°-28°E 149.0 feet to a iron in the north right of way line of Township Road #269.

Thence S79°-32°W 40.0 feet to a iron.

Thence Ni1°-06'W 146.3 feet to a iron on or near the waters edge of Indian Lake at Spillway Level.

Thence N720-23'E 50.0 feet to a iron.

Thence S79°-32'W 40.0 feet to a iron. Said iron is the place of beginning for this description.

Thence continuing S79°-32'W 40.0 feet to a iron.

Thence N15°-03°W 140.5 feet to a iron on or near the waters edge of Indian Lake at Spillway Level.

Thence N170-46°W 121.1 feet to a iron on or near the waters edge of Indian Lake at Spillway Level.


Thence with the waters edge of Indian Lake at Spillway Level N440-02°E 29.9 feet to a iron.

Being situate in the State of Ohio, County of Logan, Township of Washington and being a part of Virginia Military Surveys 9925, 9946, 10121, and being a part of the State of Ohio Indian Lake Excess Lands, and being more particularly described as follows:

Beginning for reference at a 7/8" diameter iron pipe found on the West line of Waterbury Summer Resort as recorded in Plat Cabinet "A", Slide 224, of the Logan County Plat Records at the Northwest corner of Lot 1 of said Waterbury Summer Resort, also being at the Southwest corner of Lot 1-A of Indian Lake Reservoir Lands, Waterbury Summer Resort as recorded in Plat Cabinet "A", Slide 581 and being 0.0148 acre tract conveyed to L. Kent Rogers, etux., by Deed recorded in Official Record 850, Page 269, of the Logan County Records;

thence with the West line of said Lot 1-A and Rogers 0.0148 acre tract N-8°18'34"-E, 3.70' (feet) to a 7/8" diameter iron pipe found at the **PRINCIPLE PLACE OF BEGINNING** for the tract hereinafter described, also being at the Northeast corner of a 0.153 acre tract conveyed to Russell D. Francis, etal., by Deed recorded in Official Record 973, Page 844, of the Logan County Records;

thence with the North line of said Francis' 0.153 acre tract and the North line of Lot 46-499 of Indian Lake Reservoir Lands as recorded in Plat Cabinet "A", Slide 485, S-71°40'05"-W, 50.00' (feet) to a 5/8" diameter iron bar found at the Northeast corner of a 0.158 acre tract conveyed to Charles F. Gesting & Rose A. Gesting, Trustees, by Deed recorded in Official Record 208, Page 894, of the Logan County Records;

thence with the West line of said Francis' 0.153 acre tract projected North, N-11°57'13"-W, 12.87' (feet) to a drill hole in concrete set on a sea wall of Indian Lake;

thence with said sea wall the following two (2) courses:

- 1. N-67°34'06"-E, 31.08' (feet) to a drill hole in concrete set;
- 2. N-59°26'59"-E, 21.51' (feet) to a drill hole in concrete set;

thence with the West line of aforementioned Lot 1-A and Rogers' 0.0148 acre tract, S-8°18'34"-E, 19.87' (feet) to the place of beginning.

Containing 0.018 acre, but being subject to the rights of all legal highways and all easements of record.

Being a part of the State of Ohio Indian Lake Excess Lands.


The herein described tract is to be attached to the adjoining 0.153 acre tract currently owned by Russell D. Francis, etal., and is not to be used as a separate and independent tract.


