Thence with the west line of said lot produced, N. $4^{\circ} 35'$ W. 17.50 feet to an iron bar, said iron bar being the beginning point for this survey;

Thence continuing N. $4^{\circ} 35'$ W. 107.10 feet to the shoreline of Indian Lake, passing through an iron bar at 95.00 feet;

Thence with the said shoreline, N. $53^{\circ} 37'$ E. 11.77 feet to a point on said shoreline;

Thence S. $4^{\circ} 35'$ E. 107.20 feet to an iron bar, passing through an iron bar at 18.30 feet;

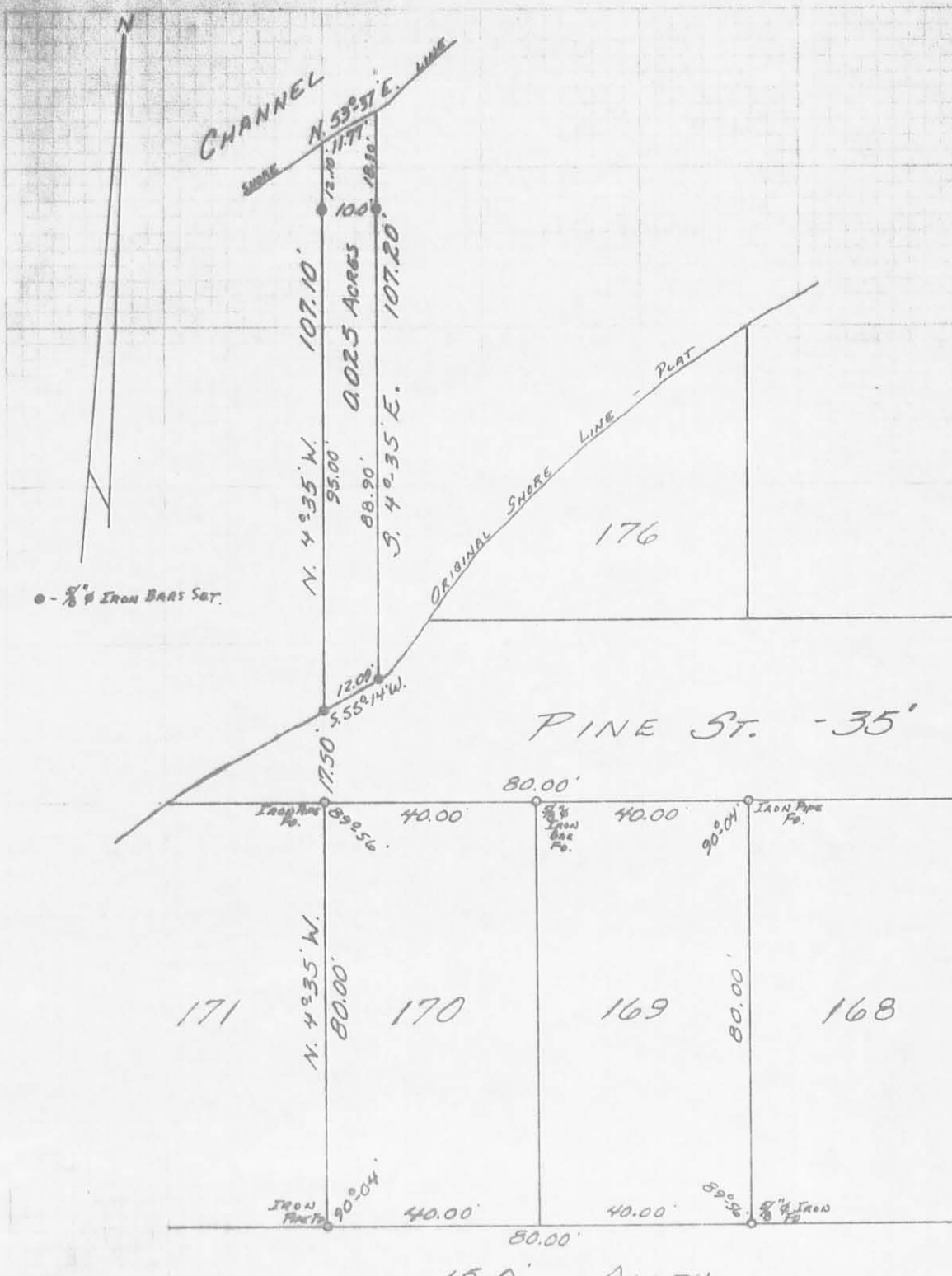

Commencing at an iron pipe in the south line of Pine Street at the northwest corner of lot 170 of said Orchard Island as shown on Logan County Recorders Plat Book B, Volume 2, Page 121; thence with the west line of said lot produced N.4° 35'W. 17.50 feet to an iron bar, said iron bar being the beginning point of this description; thence continuing N.4° 35'W. 101.0 feet to the shoreline of Indian Lake, passing an iron bar at 95.0 feet; thence with said shoreline S.59° 19'W. 33.4 feet; thence S.4° 35'E. 103.7 feet to a point in the south line of said Pine Street 30.0 feet west of the northwest corner of said lot 170, passing an iron bar at 1.0 feet; thence N.55° 14'E. 34.7 feet to the place of beginning.
