

Commencing at a railroad spike at the intersection of the centerline of Williams Street and the centerline of Center Street in the Village of Lewistown; thence with the centerline of said Center Street N.32°50'E. 183.75 feet to a railroad spike, said spike being the beginning point of this description; thence with the north line of a ten foot vacated alley N.57°10'W. 460.5 feet to an iron bar; thence with the west line of a ten foot vacated alley S.32°50'W. 183.75 feet to an iron bar in the center of said Williams Street; thence with the centerline of said Williams Street projected N.57°10'W. 240.7 feet to an iron bar in the east line of Lilian Hoover's 3.06 acre tract; thence with said Hoover's east line N.18°23'E. 325.2 feet to a wood post in the north line of said Section 24; thence with said section line N.89°43'E. 661.0 feet to an iron pipe at the northwest corner of James G. Robson's 0.48 acre tract; thence with said Robson's line S.9°10'W. 507.6 feet to a concrete post at the southwest corner of E. Eloise Robson's 0.75 acre tract; thence with said Robson's south line S.57°10'E. 25.0 feet to a railroad spike in the center of said Center Street; thence with the centerline of said street S.32°50'W. 27.3 feet to the place of beginning.

Containing 6.26 acres more or less.

street S.32° 50'W. 27.3 feet to the place of beginning.



LEGAL DESCRIPTION FOR NORVIEL'S 1.528 ACRE TRACT

Being situate in the State of Ohio, County of Logan, Township of Washington and being a part of Section 24, Town 7, Range 8, and being more particularly described as follows:

Beginning for reference at a railroad spike found at the intersection of the centerlines of County Road 54 (AKA Center Street) (66' right-of-way) and Williams Street (47.5' right-of-way) as shown on the Original Plat of Lewistown as recorded in Plat Cabinet "A", Slide 144, of the Logan County Plat Records;

thence with the centerline of said Williams Street N-56°19'39"-W, 460.35' (feet) to a 5/8" diameter iron bar found at the **PRINCIPLE PLACE OF BEGINNING** for the tract hereinafter described, said iron bar found also being at the Westerly terminus of said Williams Street and at the Southeasterly corner of a 5.82 acre tract conveyed to Lillian M. Hoover, Trustee, by Deed recorded in Official Record 151, Page 508, Tract 3, Parcel 1, of the Logan County Records;

thence with the Westerly line of said Original Plat of Lewistown, S-34°01'37"-W, 341.21' (feet) to a Mag nail found on the centerline of County Road 91, to the Northwest, (50' right-of-way), passing for reference an iron bar set on the right-of-way line of said County Road 91 at 316.20' (feet) and also passing for reference an iron bar set on the Southerly line of Williams Street at 23.75' (feet);

thence with the centerline of County Road 91 N-54°14'58"-W, 153.13' (feet) to a Mag nail set at the Southeast corner of a 5 acre tract conveyed to Lillian M. Hoover, Trustee, by Deed recorded in Official Record 151, Page 508, Tract 1, Parcel 3, passing for reference a Mag nail found at 112.33' (feet);

thence with the Easterly line of said Hoover's 5 acre tract, N-19°21'02"-E, 346.52' (feet) to a 5/8" diameter iron bar found at the Southwesterly corner of aforementioned Hoover's 5.82 acre tract, passing for reference an iron bar set on the right-of-way line of County Road 91 at 26.06' (feet);

thence with the Southerly line of said Hoover's 5.82 acre tract, S-56°18'08"-E, 240.86' (feet) to the place of beginning.

Containing 1.528 acres, 0.090 acre of which is within the road right-of-way, but being subject to the rights of all legal highways and all easements of record.

Being a more accurate description of a 1.5 acre tract conveyed to Marguerita K. Norviel, etal., by Deed recorded in Official Record 1061, Page 253, Tract 3, of the Logan County Records.

The foregoing description prepared by and in accordance with a Survey by William D. Edwards, Professional Surveyor No. 7574, August 27, 2012. All iron bars set are 5/8"x30" iron re-bar with a yellow plastic cap stamped "EDWARDS PS 4792 PS 7574". The basis of bearings for the herein described tract is the centerline of Williams Street per an assumed bearing of N-56°19'39"-W.
