thence with the North line of Lot 103 and the South line of Lot 105, S-55°29′56″-E, 100.00′(feet) to an iron bar set on the West line of a 10′ wide Alley;

thence with the West line of the Alley, S-33°42'38"-W, 10.00'(feet) to an iron bar set;

thence N-55°29'56"-W, 100.00'(feet) to an iron bar set on the East line of aforementioned Center Street;

thence with the East line of Center Street, N-33°42'38"-E, 10.00'(feet) to the place of beginning.

Containing 0.023 acre but being subject to the rights of all legal highways and all easements of record.

Being a part of Lot 103 of Lottie H. McKinnon's Addition conveyed to Lura Spees by deed recorded in Official Record 695, Page 866, of the Logan County Records.



BEGINNING at a Mag Nail set on the East line of 10' wide Alley at the Northwest corner of said Lot 104, also being the Southwest corner of Lot 106;

thence with the North line of Lot 104 and the South line of Lot 106, S-55°29′56″-E, 100.00′(feet) to a point at the North Terminus of Council Street (49.5′ right-of-way), passing for reference an iron bar set at 90.00′(feet);

thence with the West line of Council Street, S-33°42'38"-W, 10.00'(feet) to an iron bar set;

thence N-55°29′56″-W, 100.00′(feet) to a Mag Nail set on the East line of the aforementioned 10′ wide Alley;

thence with the East line of the Alley, N-33°42'38"-E, 10.00'(feet) to the place of beginning.
