## LEGAL DESCRIPTION-INDIAN LAKE LANDS WATERBURY RESORT

Being situate in the State of Ohio, County of Logan, Township of Washington, and being a part of Virginia Military Survey 9925, and being more particularly described as follows;

Beginning at a 1" diameter iron pipe found, projecting 0.3' above grade, at the Northwest corner of Lot 48 of Waterbury Resort as recorded in Plat Cabinet "A", Slide 581 of the Logan County Plat Records, said iron pipe also being at the Northwest corner of a tract owned by Scott M. Collins, etal., as recorded in Official Record 420, page 260 of the Logan County Records;

thence with the west line of Lots 48 and 47 of Waterbury Resort, also being the East line of a 20.00' wide Boulevard, vacated by Resolution No. 123-92 and recorded in Official Record 153, page 819, S-1°18'34"-W, 47.00'(feet) to a 1" diameter iron pipe found, projecting 0.2' above grade, at the Southwest corner of said Collins' tract, passing for reference the Southwest corner of Lot 48 at 40.00'(feet);

thence with the South line of said Collins' tract projected West, N-88°33'09"-W, 26.19'(feet) to a Cross-Notch set in an existing concrete sea-wall on the existing shore line of Indian Lake, passing for reference a Cross-Notch set in concrete on the West line of the mentioned vacated Boulevard at 20.00'(feet);

thence with said sea-wall and the existing shore line of Indian Lake, N-0°32'00"-E, 47.01'(feet) to a Cross Notch set in the concrete sea-wall;

thence with the North line of aforementioned Lot 48 projected West, S-88°33'09"-E, 26.83'(feet) to the place of beginning, passing for reference an iron bar set on the West line of the vacated Boulevard at 6.83'(feet).

Containing a total of 0.029 acre, 0.022 acre of which is a part of the vacated Boulevard, but being subject to the rights of all legal highways and all easements of record.

The herein described parcel is to be attached to mentioned Collins' existing and adjoining tract and is not to be used as a separate and individual parcel.

The herein described tract is a part of the excess lands of the State of Ohio.

The foregoing description prepared by William D. Edwards, Professional Surveyor No. 7574, in accordance with a field survey, November 29, 1999. All iron bars set are 5/8"x 30" iron re-bar with a yellow plastic cap stamped "EDWARDS PS 4792 PS 7574" and are set at grade. The basis of bearings for the herein described tract is the West line of Hickory Ave., 10' wide right-of-way, of Waterbury Resort, per an assumed bearing of S-3°51'09"-E.
