LEGAL DESCRIPTION FOR GREGG'S 0.791 ACRE TRACT

Being situate in the State of Ohio, County of Logan, Village of West Liberty, Liberty Township, and being a part of the Section 27, Town 5, Range 13, and being more particularly described as follows:

Beginning for reference at a ¾" iron bar found at the intersection of the centerlines of Newell Street (60' right-of-way) and Detroit Street (70' right-of-way);

thence with the centerline of said Detroit Street N-0°51'29"-E, 225.00' (feet) to a Mag nail found at the intersection of the centerlines of said Detroit Street and County Road 189 (60' right-of-way);

thence with the centerline of County Road 189 N-14°24'01"-W, 157.73' (feet) to a Mag nail found at the Southeast corner of a 0.749 acre tract conveyed to Andrew C. McGill by Deed recorded in Official Record 536, Page 421, of the Logan County Records, said Mag nail found also being at the Northeast corner of a 0.110 acre tract conveyed to William M. Harrington, etal., by Deed recorded in Official Record 24, Page 334, of the Logan County Records;

thence with the North line of said Harrington's tract and the South line of said McGill's tract N-87°59'24"-W, 143.99' (feet) to an iron bar set at the **PRINCIPLE PLACE OF BEGINNING** for the tract hereinafter described, said iron bar set being at the Northwest corner of said Harrington's tract and on the East line of a 16' (foot) wide alley at the North terminus of said alley;

thence with the West line of said Harrington's tract, the West line of a 0.09 acre tract conveyed to Jennifer J. Zinn by Deed recorded in Official Record 590, Page 295, the West line of a 0.20 acre tract conveyed to Darin C. Leach, etux., by Deed recorded in Official Record 301, Page 510, and with the West line of a 0.214 acre tract conveyed to Kelly J. Smith by Deed recorded in Official Record 829, Page 965, of the Logan County Records, and the East line of said 16' (foot) wide alley, S-0°51'43"-W, 181.86' (feet) to a 5/8" diameter iron bar with "Clapsaddle" cap found on the North line of another 16' (foot) wide alley;

thence with the North line of a 16' (foot) alley N-88°29'17"-W, 189.70' (feet) to a 5/8" diameter iron bar found at the Southeast corner of an original 74.39 acre tract conveyed to Adriel School, Inc., by Deed recorded in Official Record 12, Page 654, of the Logan County Records, passing for reference the West line of the first mentioned 16' (foot) wide alley at 16.00' (feet);

thence with the East line of said Adriel School's tract N-1°33'32"-E, 183.48' (feet) to a 5/8" diameter iron bar with "Lee" cap found at the Southwest corner of aforementioned McGill's 0.749 acre tract;

thence with the South line of said McGill's tract S-87°59'24"-E, 187.49' (feet) to the place of beginning, passing for reference the Northwest corner of a 16' (foot) alley at 171.49' (feet).

Containing 0.791 acre, 0.067 acre of which is within the mentioned 16' (foot) wide alley, but being subject to the rights of all legal highways and all easements of record including but not limited to 16.00' (feet) in width off the entire East side of the herein described tract to be used as an alley.

Being a more accurate description of a 0.5 acre tract conveyed to Virginia A. Gregg, Trustee, by Deed recorded in Official Record 901, Page 585, Tract 2, of the Logan County Records.



LOFFING 0.749 ACRE

Lying in Section 27, Town 5, Range 13, Village of West Liberty, Liberty Township, Logan County, Ohio.

Being all of the Steven T. Loffing and Andra R. Loffing 0.72 acre tract as deeded and described in Official Record 400, Page 234 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a MAG nail set at the intersection of the center-lines of Detroit Street (60 feet wide) and County Highway 189 (60 feet wide).

THENCE, with the center-line of County Highway 189, N 14°-24'-01" W, a distance of 157.73 feet to a MAG nail set at the TRUE POINT OF BEGINNING.

THENCE, with the north line of the William M. Harrington 0.11 acre tract (O.R. 24 Pg. 334), the north line of a 16 feet wide alley and the north line of the Virginia Anne Hostetler 1/2 acre tract (Vol. 348, Pg. 469, Tract II), N 87°-59'-24" W, a distance of 331.48 feet to a 5/8 inch iron rod set, passing a 5/8 inch iron rod set at 31.27 feet.

THENCE, with an east line of the Adriel School, Inc. original 74.39 acre tract (O.R. 12, Pg. 654), N 1°-21'-04" E, a distance of 99.00 feet to a 5/8 inch iron rod set.

THENCE, with the south line of the Craig L. Haidet 0.68 acre tract (Vol. 401, Pg. 317), S 89°-28'-56" E, a distance of 301.25 feet to a MAG nail set, passing a 5/8 inch iron rod set at 270.17 feet.

THENCE, with the center-line of County Highway 189, S 14°-24'-01" E, a distance of 111.38 feet to the point of beginning.

Containing 0.749 acre, of which 0.076 acre is within the highway right-of-way.

The basis for bearings is the center-line of County Highway 189, being N 14°-24'-01" W, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Co., Inc. on November 7, 2001.



SURVEY FOR SHANN KELLER 0.214 Acre November 19, 2003

The following described 0.214 acre tract is situated in the State of Ohio, County of Logan, Township of Liberty, Village of West Liberty, Section 27, Town 5, Range 13, being a re-survey of Shann Keller's 0.20 acre tract described in Official Record 545, page 54, said 0.214 acre tract being more particularly described as follows:

Beginning at a magnetic nail found at the intersection of the centerline of Detroit Street (U.S. Route #68, 70 feet wide) with the southern terminus point of the centerline of County Road #189 (60 feet wide), said nail being in the east line of said 0.20 acre tract and marking the **place of beginning**;

Thence South 14°24'01" East (assumed bearing) 30.14 feet, following the extended centerline of County Road #189 and the east line of said 0.20 acre tract, to a magnetic nail set;

Thence **North 88°29'31" West 193.44 feet**, passing at 7.93 feet the centerline of Detroit Street, and passing at 42.94 feet a magnetic nail set in the west right of way line of Detroit Street and thereafter following the north line of an area not covered by deed, said magnetic nail set bearing South 66°00'37" West 2.30 feet from a 5/8 inch iron pin found, to an iron pin set at the southeast corner of Virginia Anne Hostetler's ½ acre Tract II described in Deed Volume 348, page 469, said iron pin bearing North 56°19'43" East 0.86 feet from a ³⁄₄ inch iron pipe found;

Thence North 00°51'29" East 50.00 feet, following the east line of said ½ acre tract and the west line of said 0.20 acre tract, to a ¾ inch iron pipe found at the southwest corner of Darin C. and Laurie A. Leach's 0.20 acre tract described in Official Record 301, page 510, said iron pipe being South 00°51'29" West 50.00 feet from a ¾ inch iron pipe found at the northwest corner of said Leach's 0.20 acre tract;

Thence **South 88°29'31" East 179.75 feet**, following the south line of Leach's 0.20 acre tract and the north line of Keller's 0.20 acre tract, passing at 148.56 feet an iron pin set in the west right of way line of County Road #189, to a magnetic nail set in the centerline of County Road #189;

Thence **South 14°24'01" East 21.85 feet**, following the centerline of said Road and the east line of said 0.20 acre tract, to the **place of beginning**, **containing 0.214 acre**, more or less, and being subject to all valid easements and restrictions of record. Of the above described 0.214 acre tract, 0.042 acre is within the right of way of County Road #189 and U.S. Route #68.





Mennonite Board of Missions and Charities - Lehman Survey
Liberty Township January 1960 0.68 Acre

The following described land in the Village of West Liberty, Liberty Township, Logan County, Ohio and being in Section 27 Town 5 Range I3.

Beginning at a small iron in the center of U.S.Route Number 68 (Being the old location of said U.S.Route 68 leading along the west side of the West Liberty Cemetery) at the N.E. corner of Zellah B. McClain's 0.72 acre tract and at the S.E. corner of The Mennonite Board of Missions and Charities present T.80 acre tract.

Thence with the north line of said Zellah B. McClain's 0.72 acre tract and with the south side of said popph/b/ Mennonite Board of Missions and Charities present I.80 acre tract N.84 - 20 W. 30I.75 feet to an iron at the N.W. corner of said McClain's 0.72 acre tract and also being the S.W. corner of said I.80 acre tract and also being in the East line of Mennonite Board of Missions and Charities I6.75 acre tract. The last described line passing an iron at 3I.08 feet (Being 30.00 feet from the center line of said W.S. 68 when measured at right angles)

Thence with the East side of said I6.75 acre tract and with the West side of said Mennonite Board of Missions and Charities I.80 acre tract N. 6 - 30 E. IO4.00 feet to an iron.


Thence S. 84 - 20 E. 272.00 feet to a small iron in the center of said U.S. Route 68 the last described line passing an iron at 240.92 feet (Being 30.00 feet from the center line of said U.S. Route 68 when measured at right angles)

Thence with the center line of said U.S.Route 68 S. 9 - 31 E. 107.75 feet to the place of beginning. Said described tract containing 0.68 of one acre.

The above described 0.68 acre tract being off of the south side of the present I.80 acre tract now in the name of The Mennonite Board of Missions and Charities.
