AN ORDINANCE VACATING AN ALLEY Moe// AND DECLARING AN EMERGENCY

WXX

WHEREAS, the owner of a residence located at 212 East Newell Street has contacted the Planning Commission requesting an alley be vacated, and the Planning Commission approves of such vacation; and

WHEREAS, the alley runs north and south between East Newell Street and an alley running east and west between Liberty Street and McClellan Street;

WHEREAS, there is good cause for vacation, in that improvements have been constructed in the alley; and

WHEREAS, vacation will not be detrimental to the general interest, in that the alley is not and has not been used or maintained as an alley; and

WHEREAS, there are only two landowners abutting the alley, and each such landowner has consented in writing to the vacation.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of West Liberty, Logan County, Ohio, that:

Section 1. The alley that runs north and south between East Newell Street and an alley running east and west between Liberty Street and McClellan Street, more particularly described on Exhibit A attached hereto, is hereby vacated.

Section 2. This Council finds and determines that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in open meetings of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

Section 3. This ordinance is declared to be an emergency measure, necessary for the preservation of the public health and safety of the Village, to avoid liability for failing to remove an obstacle from the alley way.


