LEGAL DESCRIPTION FOR STOUT'S 1.969 ACRE TRACT

Being situate in the State of Ohio, County of Logan, Village of West Liberty, Liberty Township, and being a part of Section 27, Town 5, Range 13, B.T.M.R.S., and being more particularly described as follows;

Beginning for reference at a cross-notch in concrete set at the intersection of the East line of Detroit Street (U. S. Route 68) (variable width right-of-way) and the South line of Baird Street (60' right-of-way);

thence with the South line of Baird Street, S-88°28'46"-E, 392.39' (feet) to a ¾" diameter iron bar in concrete found at the Northwest corner of that part of Lot 236 of the R. N. Jordan Addition as recorded in Plat Cabinet "A", Slide 69, of the Logan County Plat Records conveyed to James E. Stout by Deed recorded in Deed Volume 338, Page 885, Tract 2, of the Logan County Deed Records, also being at the Northeast corner of a 1.485 acre tract conveyed to Robert N. Lingrel by Deed recorded in Official Record 236, Page 299, of the Logan County Records;

thence with the West line of said Stout's tract and with the East line of said Lingrel's tract, S-1°36'04"-W, 360.30' (feet) to an iron bar set at the PRINCIPLE PLACE OF BEGINNING for the tract hereinafter described;

thence with the South line of a 0.31 acre tract conveyed to Grayson L. Atha by Deed recorded in Official Record 112, Page 858 and the South line thereof projected West, N-87°32'49"-E, 345.96' (feet) to a 5/8" diameter iron bar with "Gilbert" cap found at the Southeast corner of said Atha's 0.31 acre tract, also being at the Southwest corner of a 0.114 acre tract conveyed to Scott A. Boyd, etal., by Deed recorded in Official Record 431, Page 970, passing for reference a 4" diameter wood post found at the Southwest corner of said Atha's 0.31 acre tract at 76.14' (feet);

thence N-85°47'48"-E, 100.62' (feet) to a 5/8" diameter iron bar with "Gilbert" cap found at the Southeast corner of said Boyd's 0.114 acre tract, also being on the West line of a 17.524 acre tract also conveyed to Scott A. Boyd, etal., by Deed recorded in Official Record 309, Page 850, Tract 5, of the Logan County Records;

thence with the West line of said Boyd's 17.524 acre tract, S-0°51'01"-W, 221.30' (feet) to a 5/8" diameter iron bar found at the Northeast corner of an original 7.716 acre tract conveyed to Thoman Brothers Super Market, Inc., by Deed recorded in Official Record 483, Page 818, of the Logan County Records:

thence with the North line of said Thoman Brothers 7.716 acre tract, N-85°39'33"-W, 448.62' (feet) to an iron bar set at the Southeast corner of aforementioned Lingrel's 1.485 acre tract;

thence with the East line of said Lingrel's tract N-1°36'04"-E, 165.20' (feet) to the place of beginning.

Containing 1.969 acres, but being subject to the rights of all legal highways and all easements of record.

Being all of a 0.63 acre tract conveyed to James E. Stout & Dorothy J. Stout by Deed recorded in Deed Volume 380, Page 159, of the Logan County Deed Records, and a part of a 1.67 acre tract also conveyed to James E. Stout & Dorothy J. Stout by Deed recorded in Deed Volume 338, Page 885, Tract 3, of the Logan County Deed Records


The herein described tract is to be attached to an adjoining tract and is not to be used as a separate and independent parcel.



Being 25' - 2'' off the west side of Lot 235. Tract Two:

Being a strip of land off the east side of Lot 236 that is described as follows:

Beginning at the southeast corner of Lot 236.

Thence with the east line of Lot 236 N 2° – 30°W 238.2 feet to a point in the south line of Baird Street.

Thence with the south line of Baird Street S 88° - 42°W 43.1 feet to a iron.

Thence N 2° - 30'W 50.0 feet to a corner post.


Thence with the south line of Lots 235, 234, and 233 N 84° - 38'E 272.5 feet to the place of beginning.
