#### LEGAL DESCRIPTION FOR LINGREL'S 0.384 ACRE TRACT

Being situate in the State of Ohio, County of Logan, Village of West Liberty, Liberty Township, and being a part of Section 27, Town 5, Range 13, B.T.M.R.S., and being more particularly described as follows:

Beginning for reference at a cross-notch in concrete set at the intersection of the East line of Detroit Street (U. S. Route 68) (variable width right-of-way) and the South line of Baird Street (60' right-of-

thence with the South line of Baird Street, S-88°28'46"-E, 392.39' (feet) to a 3/4" diameter iron bar found in concrete at the Northeast corner of a 1.485 acre tract conveyed to Robert N. Lingrel by Deed recorded in Official Record 236, Page 299, of the Logan County Records, also being at the Northwest corner of that part of Lot 236 of the R. N. Jordan Addition as recorded in Plat Cabinet A, Slide 69, of the Logan County Plat Records, conveyed to James E. Stout by Deed recorded in Deed Volume 338, Page 885. Tract 2, of the Logan County Deed Records, passing for reference a 1" diameter iron pipe found at the Northwest corner of said Lingrel's tract at 266.86' (feet);

thence with the East line of said Lingrel's tract and with the West line of said Stout's tract and with the West line of a 1.67 acre tract also conveyed to James E. Stout by Deed recorded in Deed Volume 338, Page 885, Tract 3, of the Logan County Deed Records, S-1°36'04"-W, 365.30' (feet) to an iron bar set at the PRINCIPLE PLACE OF BEGINNING for the tract hereinafter described;

thence continuing with the East line of said Lingrel's tract and the West line of Stout's 1.67 acre tract, S-1°36'04"-W, 160.20' (feet) to an iron bar set at the Southwest corner of said Stout's tract, also being the Southeast corner of said Lingrel's tract, and being on the North line of an original 7.716 acre tract conveyed to Thoman Brothers Super Market, Inc., by Deed recorded in Official Record 483, Page 818, of the Logan County Records;

thence with the North line of said 7.716 acre tract, N-85°24'22"-W, 95.12' (feet) to a 5/8" diameter iron bar with "Lee" cap found at the Southwest corner of aforementioned Lingrel's 1.485 acre tract, also being at the Southeast corner of a 0.37 acre tract conveyed to Thoman Brothers Super Market, Inc., by Deed recorded in Official Record 5, Page 622, Tract 2, of the Logan County Records;

thence with the East line of said 0.37 acre tract and with the East line of a 0.49 acre tract conveyed to Shirley A. Hostetler by Deed recorded in Official Record 560, Page 557, of the Logan County Records, N-11°43'40"-W, 142.28' (feet) to an iron bar set, passing for reference a 5/8" diameter iron bar with "Gilbert" cap found at the Southeast corner of said Hostetler's tract at 100.43' (feet);

thence N-84°06'56"-E, 128.89' (feet) to the place of beginning.

Containing 0.384 acre, but being subject to the rights of all legal highways and all easements of record.

Being a part of a 1.485 acre tract conveyed to Robert N. Lingrel by Deed recorded in Official Record 236, Page 299, of the Logan County Records.


The herein described tract is to be attached to an adjoining tract and is not to be used as a separate and independent parcel.

## EARL DAVIDSON SURVEY (NEW SURVEY)

Lying in the Village of West Liberty, Section 27, T-5, R-13, Liberty Township, Logan County, Ohio.

Embracing that same land as described in Volume 401, Page 565 of the Logan County Records of Deeds and being a consolidation of all six (6) tracts shown therein as being parts of Lot No. 2, Lot No. 3, the west part of 236, plus additional acreage south of these part lots. The boundary of the entire consolidation being described as follows:

Beginning at an iron rod set on the south line of Baird Street a distance of 246.30 feet easterly along said south line from the east line of Detroit Street. This point being the northwest corner of tract 1 and the northwest corner of this survey.

THENCE, with said south line of Baird Street, N 87°-30° E, a distance of 125.95 feet to an iron rod found marking the northeast corner of Tract 4 (After exception) and being the northeast corner of this survey.

THENCE, with the east lines of Tract 4 and Tract 6, S 2°-26'-50" E, a distance of 525.48 feet to an iron rod found marking the southeast corner of said Tract 6 at a fence corner.

THENCE, with the south line of Tract 6, N 89°-25'-20" W, a distance of 95.46 feet to an iron rod set at the southwest corner of said Tract 6 at a fence corner.

THENCE, continuing with the west line of Tract 6, N 11°-07° E, a distance of 105.77 feet to an iron pipe found marking the northwest corner of Tract 6, the same being the southeast corner of Tract 5.
