## STEVEN M. HEATH 0.317 ACRE

Lying in Section 27, Town 5, Range 13, Village of West Liberty, Liberty Township, Logan County, Ohio.

Being all of the Steven M. Heath 0.22 acre (deed) tract as deeded and described in Official Record 7, Page 466 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a PK nail set at the intersection of the center-line of McClellan Street (60 feet wide) and the north line of Columbus Avenue (70 feet wide).

THENCE, with the north line of Columbus Avenue, N 87°-31'-21" E, a distance of 155.00 feet to a 5/8 inch iron rod set at the southeast corner of the Edwin E. Hoffman 0.75 acre tract (Vol. 399, Pg. 15) and the TRUE POINT OF BEGINNING.

THENCE, with the east line of the said 0.75 acre tract, N 2°-32'-22" W, a distance of 149.87 feet to a 5/8 inch iron rod set.

THENCE, with the south line of Ruth Alley (16.5 feet wide), N 87°-34'-30" E, a distance of 97.71 feet to a 5/8 inch iron rod set.

THENCE, with the west line of the Betty B. Johnson 0.17 acre tract (Vol. 300, Pg. 699, O.R. 152, Pg. 740, and O.R. 176, Pg. 176), S 1°-40'-34" W, a distance of 150.17 feet to a 5/8 inch iron rod set.

THENCE, with the north line of Columbus Avenue, S 87°-31'-21" W, a distance of 86.67 feet to the point of beginning.

Containing 0.317 acre.

The basis for bearings is based upon the south line of Ruth Alley being N 87°-34'-30" E, and all other bearings are from angles and distances measured in field survey by Lee Surveying and Mapping Company on October 26, 1993.




