Commencing on a MAG spike set on the intersection of the center-line of Center Street and the east right-of-way of Conrail Railroad.

THENCE, with the center-line of Center Street (60 feet wide), the following two courses:

N 85°-24'-57"E, a distance of 37.98 feet to a MAG spike set.

S 80°-06'-20"E, a distance of 132.00 feet to a MAG spike set at the TRUE POINT OF BEGINNING.

THENCE, with the east lines of the Jerry Regula 2.702 acre tract and 3.368 acre tract (O.R. 120, Pg. 146, Tracts XII and V), N 11°-10'-17"E, a distance of 575.07 feet to a 5/8 inch iron rod found, passing a 1/2 inch iron pipe found at 30.01 feet.

THENCE, with the south line of the Jerry Regula 70.25 acre tract (O.R. 120, Pg. 146, Tract II), S 79°-25'-01"E, a distance of 75.02 feet to a 5/8 inch iron rod found.

THENCE, with the west line of the Michael D. Endsley 0.62 acre tract (O.R. 112, Pg. 916), S 11°-10'-17"W, a distance of 574.17 feet to a MAG spike set on the center-line of Center Street, passing a 5/8 inch iron rod set at 544.16 feet.

THENCE, with the center-line of Center Street, N 80°-06'-20"W, a distance of 75.04 feet to the point of beginning.

Containing 0.990 acre.

The basis for bearings is the center-line of Center Street, being N 80°06'-20"W, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Co., Inc. on November 2, 2007.
