FIFTH-THIRD BANK, TRUSTEE 73.061 ACRES

Lying in Virginia Military Survey 3155, Zane Township, Logan County, Ohio.

Being all of the Fifth-Third Bank, Trustee, 73.07 acre tract as deeded and described in Volume 348, Page 397 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a railroad spike found on the east line of Virginia Military Survey 3155 at the intersection of the center-lines of County Highway 144 and Ohio Route 287.

THENCE, with the east line of Virginia Military Survey 3155 and the center-line of County Highway 144 (width varies), N 33°-30'-40" W, a distance of 495.94 feet to a MAG nail set at the TRUE POINT OF BEGINNING.

THENCE, with the north line of the James A. Craft, Jr. 5.0 acre tract (O.R. 121, Pg. 13), S 53°-34'-33" W, a distance of 891.38 feet to a 5/8 inch iron rod found, passing a concrete right-of-way monument found on center-line station 682+44.48, 65 feet left, (LOG-33-31.33, sheet 2 of 25) at 65.08 feet and a 5/8 inch iron rod set at 834.44 feet.

THENCE, with the center-line of Ohio Route 287, S 50°-30'-00" W, a distance of 758.61 feet to a 3/4 inch iron rod found.

THENCE, with the east line of the Fifth-Third Bank, Trustee, 92.98 acre tract (Vol. 344, Pg. 604), N 36°-53'-00" W, a distance of 1878.30 feet to a 5/8 inch iron rod set, passing a 5/8 inch iron rod set at 30.03 feet.

THENCE, with the north line of Virginia Military Survey 3155 and the south line of the Hugh B. Showe, II, etal., Trustee, 104.36 acre tract (O.R. 199, Pg. 260, Tract One), N 52°-19'-34" E, a distance of 1764.58 feet to a MAG nail set, passing a concrete right-of-way monument found on center-line station 663+67.69, 70 feet left, at 1694.38 feet.

THENCE, with the west line of Virginia Military Survey 3155 and the center-line of County Highway 144, the following two (2) courses:

S 33°-19'-27" E, a distance of 1451.65 feet to a MAG nail set.

ROBERT TEVIS SURVEY 1.161 ACRES June 22, 2011

The following described 1.161 acre tract of land is situated in Virginia Military Survey 3155, the Village of Middleburg, Zane Township, Logan County, Ohio and being all of Robert Dale Tevis' 1.16 acre tract described in Official Record Volume 952, page 875, said 1.161 acre tract more particularly described as follows:

Beginning for reference at a 5/8 inch iron bar found at the intersection of the centerline of County Road 152 (50 feet wide) with the centerline of Township Road 227;

Thence North 1°20'23" West 504.90 feet, following the centerline of County Road 152, to a railroad spike found at the southwest corner of said 1.16 acre tract and at an angle point in the west line of The Nature Conservancy's 92.98 acre tract described in Official Record Volume 732, page 3, said railroad spike marking the **place of beginning**;

Thence North 1°20'23" West 312.10 feet, continuing along the centerline of County Road 152 and following the west line of said 1.16 acre tract, to a railroad spike found at another angle point in the west line of said 92.98 acre tract;

Thence **North 88°59'37"** East 170.50 feet, departing from the centerline of County Road 152, following the north line of said 1.16 acre tract and the west line of said 92.98 acre tract, passing a 5/8 inch iron bar found at 25.00 feet, to a 5/8 inch iron bar found;

Thence South 34°39'03" East 153.03 feet, following the east line of said 1.16 acre tract and continuing along the west line of said 92.98 acre tract, to a 5/8 inch iron bar found;

Thence South 52°54'47" West 313.62 feet, following the south line of said 1.16 acre tract and continuing along the west line of said 92.98 acre tract, passing an iron bar set at 282.82 feet, to the place of beginning, containing 1.161 acres, more or less, and subject to all valid easements and restrictions of record.

Of the above-described 1.161 acre tract of land, 0.174 acre is within the road right-of-way of County Road 152.

The above description was prepared from an actual field survey made by George A. Blackburn, Registered Surveyor #7873, during the month of June 2011. Iron bars set are 5/8 inch by 30 inch reinforcing rods with plastic caps marked "Blackburn RS #7873." Bearings indicated herein are based on the centerline of County Road 152 (50 feet wide) bearing North 1°20'23" West.


