Hatcher's 4.347 acre tract described in Official Record 283, page 595 and at the westernmost corner of Michael and Johnna L. Colyer's 5.532 acre tract described in Official Record 318, page 982;

Thence **South 46°00'16"** East 331.43 feet, following the northeast line of said original 8.75 acre tract, the southwest line of said 5.532 acre tract, and the northwest line of Allen B. and Rosann O. Shirk's 106.992 acre tract described in Official Record 181, page 439, leaving V.M.S. 4570 and entering V.M.S. 9657, passing a 5/8 inch iron pin found at 205.40 feet, to a 5/8 inch iron pin found;
