Lying in the Virginia Military Survey 3155, Village of Middleburg, Zane Township, Logan County, Ohio.

Being all of the Daniel L. Lininger, 0.127 acre tract as deeded and described in Volume 370, Page 324 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a 5/8 inch iron rod set at the intersection of the north line of Green Street (60 feet wide) with the east line of North Street, (60 feet wide) in said Village of Middleburg.

THENCE, with the said east line of North Street, N 42°-30' W, a distance of 39.39 feet to a 5/8 inch iron rod set at the southwest corner of the Helen Fisher property (O.R. 4, Page 645). This point being, S 42°-30' E. a distance of 236 feet from the south line of Urbana Street.

THENCE, with the line between Lininger and Fisher, N 46°-55' E, a distance of 110.50 feet to a 5/8" iron rod set.

THENCE, with the line between Lininger and Agnes Cole (Volume 362, Page 21), S 42°-30' E, a distance of 61.08 feet to a 5/8 inch iron rod set on the north line of Green Street.

THENCE, with said north line of Green Street, S 58°-02'-30" W, a distance of 112.39 feet to the point of beginning.

Containing 0.127 acre (5551 square feet).

The basis for bearings is based upon the east line of North Street being N 42°-30'-00" W, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Company on April 18, 1986.



Williams' 0.40 acre tract (0.441 acre by this survey) described in Official Record 106, page 884, and being more particularly described as follows:

Beginning for reference at the south corner of Lot 53 of the Village of Middleburg and the west corner of said 0.40acre tract, said corner being in the northeast right of way line of North Street (60 feet wide);

thence South 42°28'38" West (bearing based on an assumed meridian with all others based on angles turned) 5.76 feet, following the northeast right of way line of North Street and the southwest line of said 0.40 acre tract, to a 5/8" iron pin set with cap marked "CLAPSADDLE RS 6140," said iron pin set marking the place of beginning;

thence North 49°02'30" East 196.56 feet, crossing said 0.40 acre tract, to a 5/8" iron pin set with cap marked "CLAPSADDLE RS 6140" in the southwest line of Clarence E. and Martha Fletcher's 0.41 acre tract described in deed volume 405, page 814, and in the northeast line of said 0.40 acre tract:

thence South 42°28'28" East 85.75 feet, following the southwest line of said 0.41 acre tract and the northeast line of said 0.40 acre tract, to a 5/8" iron pin found with cap marked "CLAPSADDLE RS 6140" in the northwest line of George Blackburn's 0.18 acre tract described in Official Record 48, page 399;

thence South 46°57'07" West 86.00 feet, following the northwest line of said 0.18 acre tract and the southeast line of said 0.40 acre tract, to a 1" iron pipe found at the north corner of Brett A. and Susan A. Herron's 0.12 acre tract described in Official Record 72, page 566;

thence South 46°54'29" West 110.50 feet, following the northwest line of said 0.12 acre tract and the southeast line of said 0.40 acre tract, to a 5/8" iron pin found in the northeast right of way line of North Street;

thence North 42°28'38" West 93.00 feet, following the northeast right of way line of North Street and the southwest line of said 0.40 acre tract, to the place of beginning, containing 0.403 acre, more or less, and subject to all valid easements and restrictions of record.


