THENCE, with the southerly line of Virginia Military Survey 3753 and the center-line of Township Road 29 (40 feet wide), N 53°-00'-00" E, a distance of 1268.62 feet to a MAG nail set at the TRUE POINT OF BEGINNING.

THENCE, N 35°-45'-55" W, a distance of 290.47 feet to a 5/8 inch iron rod set, passing a 5/8 inch iron rod set at 20.00 feet.

THENCE, N 53°-00'-00" E, a distance of 150.00 feet to a 5/8 inch iron rod set.

THENCE, S 35°-45'-55" E, a distance of 290.47 feet to a MAG nail set, passing a 5/8 inch iron rod set at 270.47 feet.
