ANNEXATION PLAT OF 1.163 ACRES

DESCRIPTION

The following described real estate situated in the Township of Lake, County of Logan, State of Ohio and being a part of Virginia Military Survey No. 3683 and being all of Lots No. 2, 3 and 4 in CAMPBELL ALLOTMENT as recorded in Plat Cabinet A, Slide 317 (4-30-1955) and now being more particularly described as follows:

Beginning at a 3/4" Iron Pipe found at the southeast corner to Lot No. 4 of said CAMPBELL ALLOTMENT, the southwest corner to a 1.21 Acre in the name of Robert L. Cooper, Jr. et ux as recorded in Deed Volume No. 400 Page 540 (6-8-1983) and being in the northline of Campbell Avenue (40' wide), which is also the existing Corporation Line of the City of Bellefontaine;

Thence with the south line of Lot No. 4 and the north line of Campbell Avenue, which is also the existing Corporation Line, S. 83°-33'-59" W. 150.00' feet to a 5/8" x 30" Rebar set at the southwest corner to Lot No. 4 and being the east line of Lakewood Drive (40' wide);

Thence with the west line of Lots No. 4, 3 and 2 and also being the east line of Lakewood Drive, N. 6°-09'-00" W. 338.05' feet to a 3/4" Iron Pipe found at the northwest corner to Lot No. 2 and being the southwest corner to Lot No. 1. (Note: The east line of Lakewood Drive and the west line of Lots No. 2, 3 and 4 is the Basis of Bearing - N. 6°-09'-00" W.);

Thence with the line between Lot No. 1 and 2, N. 83°-51'-00" E. 150.00' feet to a 3/4" Iron Pipe found at the northeast corner to Lot No. 2 and the northwest corner to said 1.21 Acre tract and being in the south line of a 0.90 Acre tract in the name of John M. Elliott et ux as recorded in Deed Volume No. 317 Page 121 (10-20-1967), passing the southeast corner to Lot No. 1 at 146.10' feet;

Thence with the east line of Lots No. 2, 3 and 4 of CAMPBELL ALLOTMENT and the west line of Cooper's 1.21 Acre tract, S. 6°-09'-00" E. 337.30' feet to the place of beginning, containing 50,652.145 square feet or 1.163 Acres, more or less.
