TO HAVE AND TO HOLD said easement and right-of-way unto the Grantee, its successors and assigns forever.

And the said Grantors, for themselves and their heirs, executors, and administrators, hereby convey with the said Grantee, its successors and assigns that they are the true and lawful owners of the premises and are lawfully seized of the same in fee simple, and have given, right and full power, to grant, bargain, sell, convey and release the same, in manner aforesaid and that the same are free and clear from all liens and encumbrances whatsoever, and that they will warrant and defend the same against all claims of all persons whosoever.

And for the consideration aforesaid we hereby relinquish to said Grantee, its successors and assigns, all right and expectancy of Dower in the above described premises.
